

## Consumer Member Privacy Notice

<b>FACTS</b>	<b>WHAT DOES BETHPAGE FEDERAL CREDIT UNION DO WITH YOUR PERSONAL INFORMATION?</b>
<b>WHY?</b>	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share and protect your personal information. Please read this notice carefully to understand what we do.
<b>WHAT?</b>	The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> <li>▪ Social Security number and employment information</li> <li>▪ account balances and transaction history</li> <li>▪ credit history and payment history</li> </ul>
<b>HOW?</b>	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Bethpage Federal Credit Union ("Bethpage") chooses to share; and whether you can limit this sharing.

**What we do**

<p><b>How does Bethpage protect my personal information?</b></p>	<p>To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards, secured files and buildings.</p>
<p><b>How does Bethpage collect my personal information?</b></p>	<p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"> <li>▪ open an account</li> <li>▪ apply for a loan or use your credit or debit card</li> <li>▪ make deposits or withdrawals from your account</li> <li>▪ give us with your income information, or provide employment information</li> </ul> <p>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</p>
<p><b>Why can't I limit all sharing?</b></p>	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> <li>▪ sharing for affiliates' everyday business purposes - information about your creditworthiness</li> <li>▪ affiliates from using your information to market to you</li> <li>▪ sharing for nonaffiliates to market to you</li> </ul> <p>State laws and individual companies may give you additional rights to limit sharing. See below for more information on your rights under state laws.</p>
<p><b>What happens when I limit sharing for an account I hold jointly with someone else?</b></p>	<p>Your choice will apply to everyone on your account—unless you tell us otherwise.</p>

**Definitions**

<p>Affiliates</p>	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> <li>▪ <i>Our affiliates include companies such as: Bethpage Management Services, LLC; Bethpage Risk Management Services, LLC; Bethpage Commercial, LLC; Universal Sharing Network; CU Cooperative Systems, Inc.; CU Direct Corporation; Member Development Company, LLC; Shared Services Solutions, LLC; Bethpage Services Group, LLC; Open Technology Solutions, LLC; and Land Bound Services, LLC.</i></li> </ul>
<p>Nonaffiliates</p>	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> <li>▪ <i>Bethpage does not share with nonaffiliates so they can market to you.</i></li> </ul>
<p>Joint marketing</p>	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> <li>▪ <i>Our joint marketing partners include insurance companies and financial product or service companies.</i></li> </ul>

## Other Important Information

**California Residents:** We will not share information we collect about you with nonaffiliated third parties, except as permitted by California law, such as to process your transactions or to maintain your account. **Nevada residents:** Nevada law requires us to disclose that you may request to be placed on Bethpage's internal "do not call" list at any time by calling 1-800-628-7070 or by visiting [lovebethpage.com/optout](https://lovebethpage.com/optout) and that we are providing this notice to you pursuant to state law, and that you may obtain further information by contacting the Nevada Attorney General, 555 E. **Vermont residents:** In accordance with Vermont law, we will not share information we collect about you with nonaffiliates, except as permitted by law.
